- 7. Review and discuss financial and operational matters related to CCEMS, including:

 - b. requests for additional funding and/or resources;
 - c. corrected CCEMS Audit for Fiscal Years Ended ("FYE") December 31, 2018 and 2019;
 - d. CCEMS billing/collection processes and procedures;
 - e. documents and information requested by the District from CCEMS (assets, secured loans and health insurance, etc.); and
 - f. investigation of CCEMS maintenance facility and employees related thereto;
 - Financial Report from District Treasurer and Bookkeeper, including:
 - a. approve payment of bills and issuance of checks;
 - b. review budget comparison;
 - c. review quarterly investment report; and
 - d. Amend Budget(s) for FYE December 31, 2020;
- 9. Review draft budget for FYE December 31, 2021;
- 10. Tax Assessor/Collector's Report, including review and adopt Resolution Regarding Calculation of Voter Approval Tax Rate under Texas Tax Code, Section 26.04(c-1);
- 11. Communications Report, including status of public relations ("PR") activities and miscellaneous matters from NRG Marketing Group ("NRG") and PR committee, and take any necessary actions on same;
- 12. Discuss Statements of Qualifications from emergency medical services providers, and take any necessary actions on same;
