Notice is hereby given pursuant to the Texas Government Code, Section 551, as amended that the Board of Commissioners (the "Board") of Harris County Emergency Services District No. 11 (the "District") will meet in regular session, open to the public, at **9:00 a.m., Thursday, October 21, 2021, at the Bridgestone Municipal Utility District Operations and Water Education Center, 19720 Kuykendahl Road, Spring, Texas 77379**, a location within the District, at which the subject of and matters to be considered and acted upon will include the following:

Theo đây xin thông báo, chiếu theo Bộ Luật Chính Quyền Texas, Mục 551, bản tu chính, Hội Đồng Ủy Viên ("Hội Đồng") của Cơ Quan Dịch Vụ Khẩn Cấp Số 11 Quận Harris ("Cơ Quan") sẽ họp trong phiên thường lệ và công khai, lúc **9:00 giờ sáng thứ Năm, ngày 21 tháng Mười Một, 2021, tại Trung Tâm Đào Tạo Cấp Nước và Vận Hành Cơ Quan Dịch Vụ Tiện Ích Thành Phố Bridgestone, 19720 Kuykendahl Road, Spring, Texas 77379**, một địa điểm nằm trong phạm vi Cơ Quan, và tại đó, chủ đề và các vấn đề sẽ được xem xét và thực hiện sẽ bao gồm như sau:

特此通知，根據 Texas 州政府法第 551 節（修訂版），Harris 縣緊急服務第 11 區（下稱「本區」）的管理委員會（下稱「委員會」）將召開例行會議，向公眾開放，**時間為 2021 年 10 月 21 日，星期四，上午 9:00**，在 Bridgestone 市政公用事業區運營和水務教育中心，地址是 19720 Kuykendahl Road, Spring, Texas 77379，其為本區內的一個地點，其議題以及需要考慮和採取行動的事項將包括以下內容

1. Call meeting to order and moment of silence for prayer and reflection;
2. Public comments (2 minute limit per person or 5 minute limit per subject, whichever is less);
3. Approve the minutes of the regular meeting of September 9, 2021;
4. Administration, Dispatch and Logistics Facilities Report, including:
 - a. status of construction of Phase I redevelopment of District administration property;
 - b. approve construction pay applications and/or change orders and take any other necessary action on same;
 - c. review Gross Maximum Price amendment for construction of Phase II redevelopment of District administration property from J.E. Dunn Construction Company, and take any necessary action on same;

- d. review financing options for Phase II redevelopment of District administration property, and take any necessary action on same; and
- e. discuss design of Phase III redevelopment of District administration property, and take any necessary actions on same;
5. Chief Executive Officer, District Administration and Operations Report, including:
 - a. status of receipt of District assets from Cypress Creek Emergency Medical Services ("CCEMS");
 - b. status of delivery and deployment of District's vehicles;
 - c. status of entrance into First Responder Organization ("FRO") Provider Agreements with various overlapping FROs and take any necessary actions on same;
 - d. status of District's Standard Operating Policies and Procedures and take any necessary actions on same;
 - e. review and approve Clinical Affiliation Agreement with the School of EMS; and
 - f. review and approve Records Management Agreement for Release of Records with MRO Corp;
6. Review and approve leases and/or use agreements, as necessary;
7. Review and approve purchase orders and agreements for vehicles, supplies, furniture, fixtures and equipment and services for the District, as necessary;
8. Chief Financial Officer's Report including:
 - a. approve payment of bills and issuance of checks;
 - b. review investment report; and
 - c. status of transferring District's depository account(s) from BBVA to Allegiance Bank;
9. Tax Assessor/Collector's Report;
10. Communications Report, including status of public relations activities, including:
 - a. status of public relations activities; and
 - b. review and approve proposal for website building and design services from 62 Digital, LLC;
11. Review and discuss matters related to CCEMS, including:
 - a. status of second phase of Pannell Kerr Forster of Texas, P.C.'s Special District Examination Report; and
 - b. investigation of CCEMS maintenance facility and employees related thereto;
12. Attorney's Report, including:
 - a. discuss and take necessary action regarding method of conduct of May 7, 2022 General Election;
deliberar y tomar medidas sobre el método de realización del Elección General del 7 de mayo de 2022;
thảo luận và thực hiện các thủ tục cần thiết liên quan đến phương thức tiến hành Cuộc Tổng Tuyển Cử tổ chức vào ngày 7 tháng Năm, 2022;

 - b. status of *CCEMS vs. the District, et al*, and take any necessary action on same; and
 - c. review recent Public Information Act requests, status of responses to same and *District vs. Ken Paxton*;
13. Review District consultant contracts, and take any necessary actions on same;
14. Executive Session pursuant to Chapter 551, Texas Government Code, (Open Meetings Act) to discuss District matters, as may be necessary; and
15. Adjournment.

The Board of Commissioners is authorized by the Open Meetings Act to convene in closed or Executive Session for certain purposes. These purposes include: receiving legal advice from its attorney(s) pursuant to §551.071, Texas Government Code; discussing real property matters pursuant to §551.072, Texas Government Code; discussing gifts and donations pursuant to §551.073, Texas Government Code; discussing personnel matters pursuant to §551.074, Texas Government Code; and, discussing security personnel or devices pursuant to §551.076, Texas Government Code. If the Board decides to enter into Executive Session regarding any item on this agenda, the Presiding Officer will announce that an Executive Session will be held and will identify the item to be discussed and provision of the Open Meetings Act that authorizes the closed or Executive Session.
