Notice is hereby given pursuant to the Texas Government Code, Section 551, as amended that the Board of Commissioners (the "Board") of Harris County Emergency Services District No. 11 (the "District") will meet in regular session, open to the public, at **6:00 p.m., Wednesday, November 17, 2021, at the Bridgestone Municipal Utility District Operations and Water Education Center, 19720 Kuykendahl Road, Spring, Texas 77379**, a location within the District, at which the subject of and matters to be considered and acted upon will include the following:

3. Approve the minutes of the regular meeting of October 21, 2021 and special meeting of October 7, 2021;
4. Administration, Dispatch and Logistics Facilities Report, including:
 - a. status of construction of Phase I redevelopment of District administration property;
 - b. approve construction pay applications and/or change orders and take any other necessary action on same;

- c. review Gross Maximum Price amendment for construction of Phase II redevelopment of District administration property from J.E. Dunn Construction Company, and take any necessary action on same;
- d. review financing options for Phase II redevelopment of District administration property, and take any necessary actions on same; and
- e. discuss design of Phase III redevelopment of District administration property, and take any necessary actions on same;
5. Chief Executive Officer ("CEO") Report;
6. Administration Report, including:
 - a. review and approve Wastewater System Service Agreement with Klein Environmental Services Inc.;
 - b. adopt Order Declaring Property as Surplus or Salvage and Authorizing Sale or Disposal of Same; and
 - c. review and approve leases and/or use agreements, as necessary;
7. Clinical Report;
8. Compliance Report;
9. Operations Report;
10. Community Outreach Report, including implementation of Community Advisory Committee, and take any necessary action on same;
11. Review and approve purchase orders, as necessary;
12. Financial Report, including:
 - a. approve payment of bills and issuance of checks;
 - b. review investment report; and
 - c. status of transferring District's account(s) to Allegiance Bank;
13. Tax Assessor/Collector's Report;
14. Communications Report, including status of public relations activities, including:
 - a. status of public relations activities; and
 - b. status of creation of new website;
15. Attorney's Report, including:
 - a. discuss and take necessary action regarding method of conduct of May 7, 2022 General Election;
deliberar y tomar medidas sobre el método de realización del Elección General del 7 de mayo de 2022;
thảo luận và thực hiện các thủ tục cần thiết liên quan đến phương thức tiến hành Cuộc Tổng Tuyển Cử tổ chức vào ngày 7 tháng Năm, 2022;

 - b. status of *CCEMS vs. the District, et al*, including the second phase of Pannell Kerr Forster of Texas, P.C.'s Special District Examination Report; and
 - c. review recent Public Information Act requests, status of responses to same and *District vs. Ken Paxton*;
16. Review Medical Director Professional Services Agreement and CEO's performance review of the Medical Director and take necessary action in connection with same;
17. Review Executive Director (CEO) Employment Agreement with Douglas Hooten related to annual salary and performance review and take necessary action in connection with same;
18. Review District consultant contracts, and take any necessary actions on same;
19. Executive Session pursuant to Chapter 551, Texas Government Code, (Open Meetings Act) to discuss District matters, as may be necessary; and
20. Adjournment.

The Board of Commissioners is authorized by the Open Meetings Act to convene in closed or Executive Session for certain purposes. These purposes include: receiving legal advice from its attorney(s) pursuant to §551.071, Texas Government Code; discussing real property matters pursuant to §551.072, Texas Government Code; discussing gifts and donations pursuant to §551.073, Texas Government Code; discussing personnel matters pursuant to §551.074, Texas Government Code; and, discussing security personnel or devices pursuant to §551.076, Texas Government Code. If the Board decides to enter into Executive Session regarding any item on this agenda, the Presiding Officer will announce that an Executive Session will be held and will identify the item to be discussed and provision of the Open Meetings Act that authorizes the closed or Executive Session.
