Notice is hereby given pursuant to the Texas Government Code, Section 551, as amended that the Board of Commissioners (the "Board") of Harris County Emergency Services District No. 11 (the "District") will meet in regular session, open to the public, at **5:00 p.m., Tuesday, March 26, 2024, at the District's Administration Building, 18334 Stuebner Airline Road, Spring, Texas 77379**, a location within the District, at which the subject of and matters to be considered and acted upon will include the following:

 - c. review and approve Access to Electronic Health Records for Clinics/Organizations with St. Luke's Health;
7. Chief Financial Officer Report, including:
 - a. approve payment of bills and issuance of checks;
 - b. review Investment Report;
 - c. review and approve Amended Fiscal Year Ending December 31, 2024 Budget;
 - d. adopt Resolution Authorizing Participation in the TexPool Investment Pools and Designating Authorized Representatives; and
 - e. review and approve TexPool Investment Pools Participation Agreement;
8. Tax Assessor/Collector's Report;

9. Attorney's Report, including:
 - a. review recent Public Information Act requests and status of responses to same; and
 - b. review release of District patient protected health information and related depositions, and take any necessary actions on same;
10. District personnel matters;
11. District real estate matters, including review appraisal of District property and take any necessary actions on same;

These purposes include: receiving legal advice from its attorney(s) pursuant to §551.071, Texas Government Code; discussing real property matters pursuant to §551.072, Texas Government Code; discussing gifts and donations pursuant to §551.073, Texas Government Code; discussing personnel matters pursuant to §551.074, Texas Government Code; and, discussing security personnel or devices pursuant to §551.076, Texas Government Code. If the Board decides to enter into Executive Session regarding any item on this agenda, the Presiding Officer will announce that an Executive Session will be held and will identify the item to be discussed and provision of the OMA that authorizes the closed or Executive Session.
